Funds are made available to the Long Beach Area Council for the purposes of helping boys have a summer camping experience. To ensure proper use and allocations of these funds, we must ask that this form be completed.

CAMPERSHIPS WILL NOT BE GIVEN TO SCOUTS WHOSE FORMS ARE NOT COMPLETE!

1. Please submit this form to the Long Beach Scout Service Center as soon as possible, but no later than June 1. Initial allocations will be made based on completed applications, with notification letters being mailed in mid-June.
2. Incomplete applications will not be considered! Please be sure that the form is complete.
3. Campership funds are only available for LBAC camps. Scouts going to other camps are not eligible for these funds.
4. Campership awards are rarely over 50% of the camp fee. Scouts should plan to make up the difference from family, troop/pack donations, and/or donations from the chartered organization.
5. For applications received by June 1, the priority for allocation is
 - Scouts in LBAC units that participate in Friends of Scouting
 - Scouts in LBAC units
 - Scouts from other councilsApplications after June 1 are awarded as long as funding lasts.
6. Camperships are NOT transferable. Scouts who do not attend camp lose their campership; it cannot be applied to another scout in the troop/pack
7. For any questions, please contact the camping department of the Long Beach Area Council
8. Rule for Acceptance and Participation in the Camp Tahquitz program are the same for everyone without regard to race, color, national origin, sex, or disability.
